The appointment of Concurrent Auditors will initially stand for the period of One year from the date of their appointment. However, the agreement may be extended for next 12 months on the same terms and conditions, subject to the satisfactory assessment in the annual review of the performance of the Concurrent Auditor.

The Bank reserves the right to alter the schedule reflected in this document or to change the process or procedure to be applied. The Bank also reserves the right to decline to discuss the matter further with any party expressing interest. No reimbursement of cost of any type will be paid to any person submitting their application.

On receipt of intimation from the Bank regarding acceptance of the Application, the successful candidate shall be bound to execute the Contract within the timeline and implement the same from the specified date. The successful candidate shall sign an Agreement in accordance with the extant provisions and shall be liable to pay the appropriate and required stamp duty amount on the said Agreement in accordance with the Stamp laws in force in Uttarakhand.

The last date for submission of applications at above-mentioned address is **30.04.2025**. Applications received after the last date will not be entertained.

Allocation of Auditee units :

A pool of Auditors will be created for conducting the Concurrent Audit smoothly. The selected empaneled Auditors will be available with the Chief Inspector at Head Office, who will allocate the auditee units to the auditors from the pool with necessary instructions.

Eligibility

- 1. For appointment as Concurrent Auditor, the Official **should be of scale –III to Scale –V**, **superannuated** from <u>UGB/SBI/Any other RRB sponsored by SBI/Any Commercial Bank</u>.
- 2. Those going to superannuate within next 3 months can also apply.

3. The cut-off date for eligibility will be 1st April of that year, for example current empanelment cut-off date will be 01.04.2025.

4. There should not be gap of more than 2 years from the date of superannuation to date of appointment at the first occasion and later on there should not be gap of one year for subsequent renewals.

5. Proposed maximum tenure of the auditors is 5 years.

6. The Superannuated official should be below age of **69 years** as on **1st April** of respective year for renewal of agreement.

- 7. The ex-officers will be empanelled initially for a period of 1 year. If their performance is found satisfactory and depending on their suitability and requirement of the Bank, the period of empanelment will be extended/renewed for a further period of 12 months in each instance till they attain the age of 70 years as per point 4 above, keeping in view his/her good health appropriate for the work and level of expertise.
- 8. The retired official **should have completed minimum 2 years of Branch Manager/Regional Manager assignment** with satisfactory track record while in active service & also have good experience in operation preferably be from **Audit background**.
- 9. The retired official **should have never been penalised** through disciplinary proceeding while in active service, except punishment by way of censure.
- 10. The retired official **should be medically fit** which should be certified by our sponsor Bank's Doctor with all normal pathological tests.
- 11. The retired official **should be fluent in both Hindi & English languages**.

12. Those on medical leave **exceeding four months in the last year** of their service shall not be eligible to apply.

Process of Selection

As per policy guidelines.

<u>Remuneration</u>: The remuneration of the External Auditors(Retired Officer) is fixed with the approval of the Board as under:-

Retired Officer -

- (i) Home-centre: The fixed sum of Rs 40,000/- shall be payable per month.
- (ii) Non Home-centre: The fixed sum of Rs 45,000/- shall be payable per month.

Those auditors who are selected for category of <u>Home-centre</u> may claim reimbursement of **travelling-expenses not exceeding Rs. 4000/- per month** on the basis of certificate/petrol-bill.

Those auditors who are selected for category of <u>Non Home-centre</u> shall be eligible for **reimbursement of stay-expenses up to a maximum limit of Rs. 12,000/- p.m.** on actual/certificate basis. He/she shall also be entitled to claim up to a **maximum Rs 6000/- p.m.** for conveyance on actual/certificate basis.

TDS/Income Tax rules shall apply as per IT Act.

No TA/DA/Leave shall be granted to either working/retired official for the purpose of appearing in interview.
